

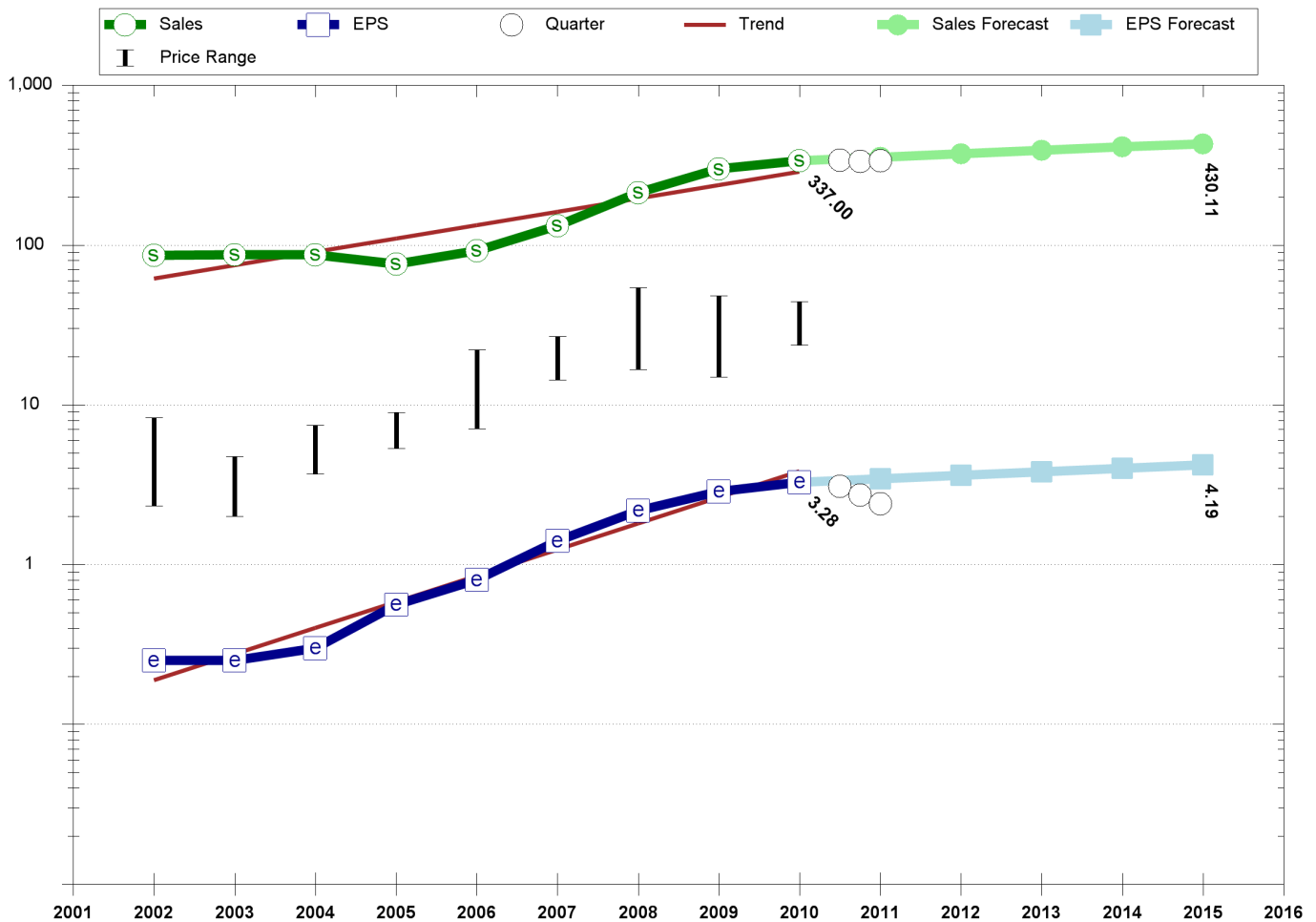

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 20.00 X Estimate High Earnings/Share 4.19 = Forecasted High Price \$ 83.80

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 7.80 X Estimate Low Earnings/Share 3.28 = Forecasted Low Price \$ 25.58

(b) Avg. Low Price of Last 5 Years 15.27

(c) Recent Market Low Price 14.35

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.000}{0.00\%} = 0.00$

C ZONING using 25%-50%-25%

Forecasted High Price 83.80 Minus Forecasted Low Price 14.35 = 69.45 Range. 25% of Range 17.36

Present Market Price of 14.65 is in the **Buy** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{83.80 - 14.65}{14.65 - 14.35} = \frac{69.15}{0.30} = 230.50$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Present Market Price}}{\text{Present Market Price}} = \frac{83.80 - 14.65}{14.65} = 5.72$ X 100 = 572.01 - 100 = 472.01 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.000}{14.65} = 0.00 = 0.00\%$ Present Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E
