

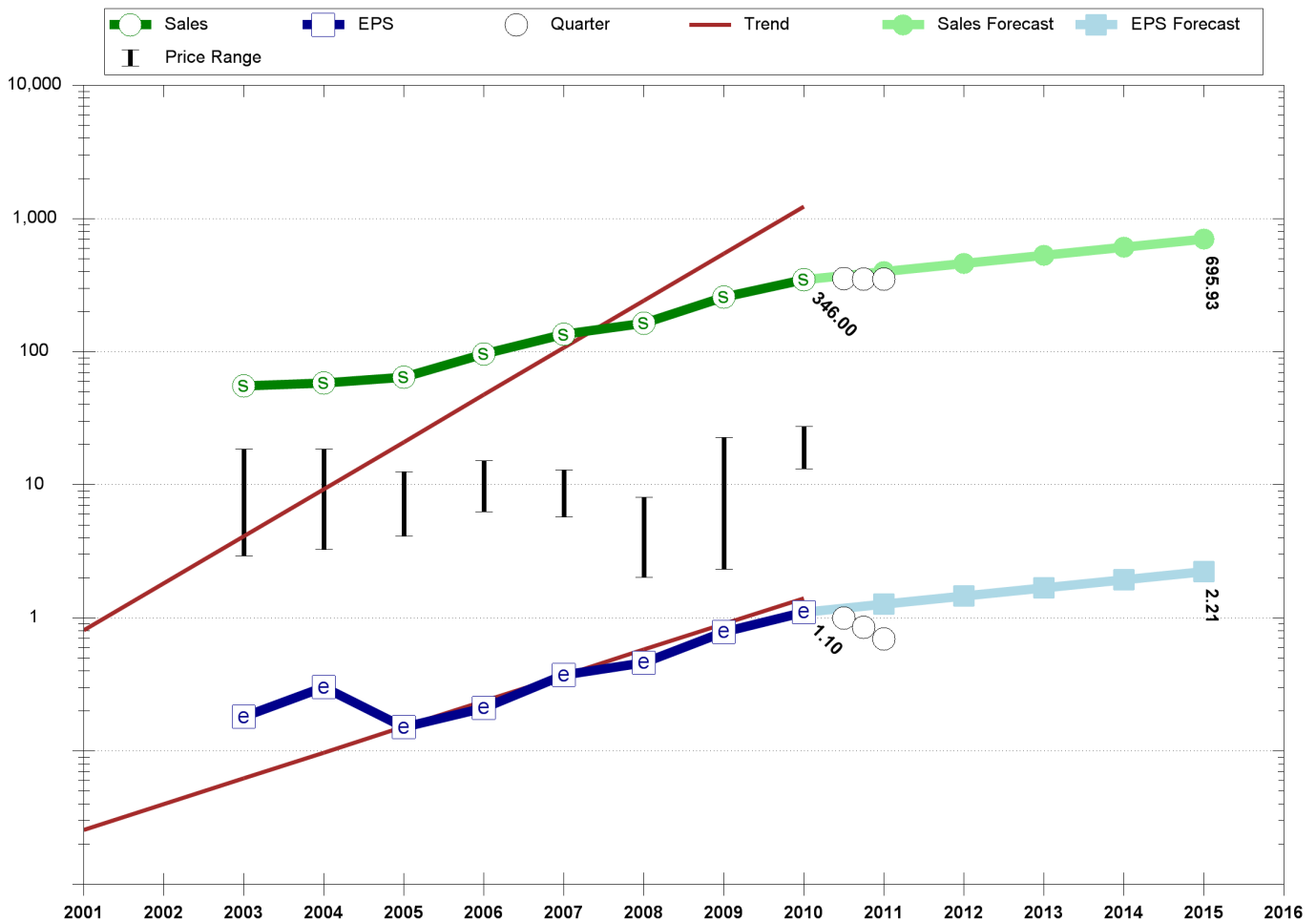

This shows how stock prices have fluctuated with earnings and dividends. It is building block for translating earnings into future stock prices.

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 20.00 X Estimate High Earnings/Share 2.21 = Forecasted High Price \$ 44.20

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 12.89 X Estimate Low Earnings/Share 1.10 = Forecasted Low Price \$ 14.18

(b) Avg. Low Price of Last 5 Years 5.88

(c) Recent Market Low Price 2.30

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.000}{0.00\%} = 0.00$

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price}} = \frac{44.20 - 4.33}{4.33} = 9.64$ To 1
 $\frac{\text{Present Price} - \text{Low Price}}{\text{Low Price}} = \frac{4.33 - 2.30}{2.30} = 0.88$

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Present Market Price}}{\text{Present Market Price}} = \frac{44.20 - 4.33}{4.33} = 10.21$ X 100 = 1,020.79 - 100 = 920.79 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.000}{4.33} = 0.00 = 0.00\%$ Present Yield
