

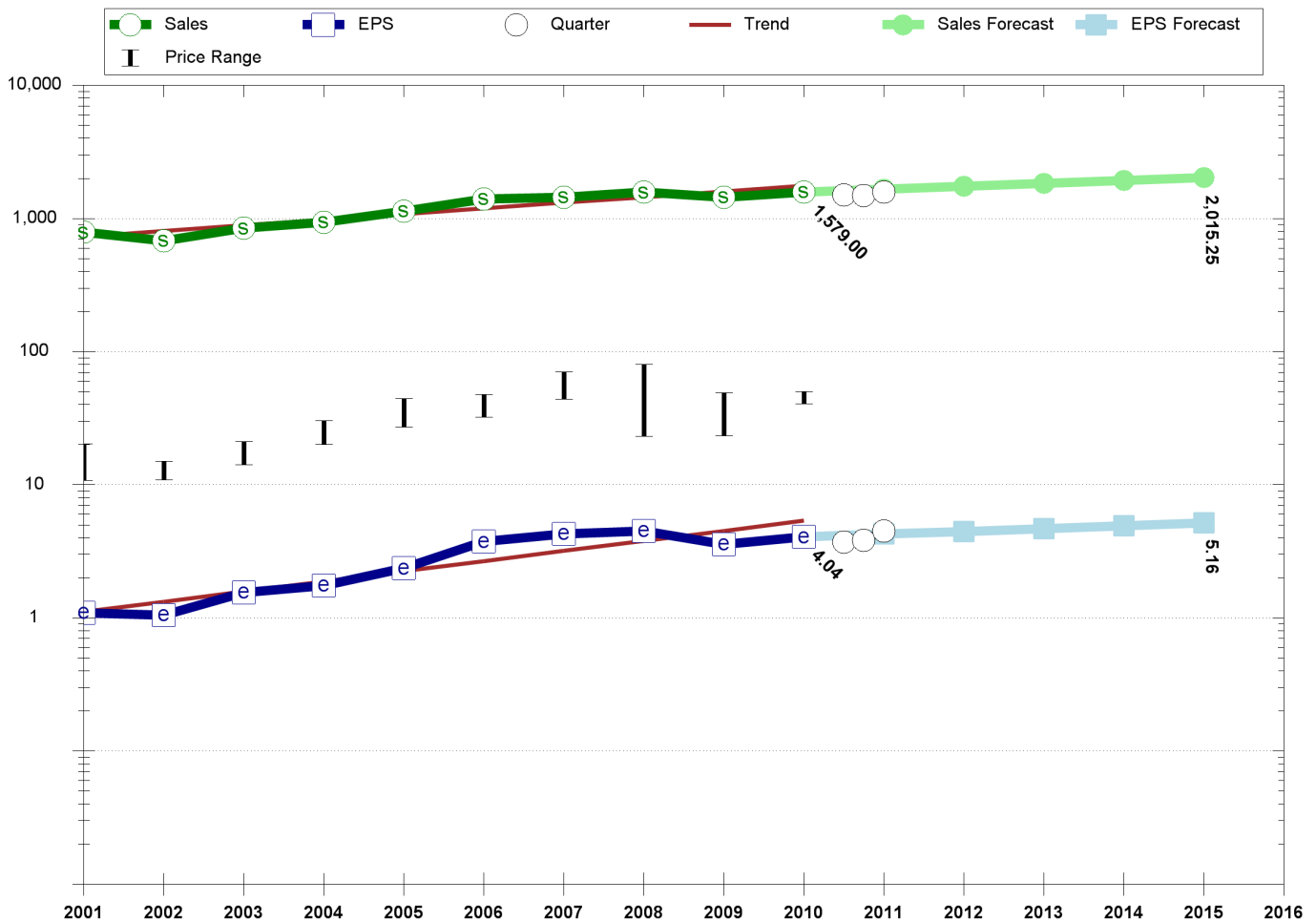

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 14.00 X Estimate High Earnings/Share 5.16 = Forecasted High Price \$ 72.24

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 8.09 X Estimate Low Earnings/Share 4.04 = Forecasted Low Price \$ 32.68

(b) Avg. Low Price of Last 5 Years 32.47

(c) Recent Market Low Price 23.18

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.540}{1.30\%} = 41.54$

Selected Forecasted Low Price 32.68

C ZONING using 25%-50%-25%

Forecasted High Price 72.24 Minus Forecasted Low Price 32.68 = 39.56 Range. 25% of Range 9.89

Buy Zone 32.68 to 42.57

Hold Zone 42.57 to 62.35

Sell Zone 62.35 to 72.24

Present Market Price of 49.34 is in the **Hold** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{72.24 - 49.34}{49.34 - 32.68} = \frac{22.90}{16.66} = 1.37$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Present Market Price}}{\text{Present Market Price}} = \frac{72.24 - 49.34}{49.34} = 1.46$ X 100 = 146.41 - 100 = 46.41 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.540}{49.34} = 0.01 = 1.09\%$ Present Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{12.03\%}{14.00} = 0.86\%$

C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E

Annualized Appreciation 7.92 %

Average Yield 0.86 %

Annualized Rate of Return 8.78 %
