

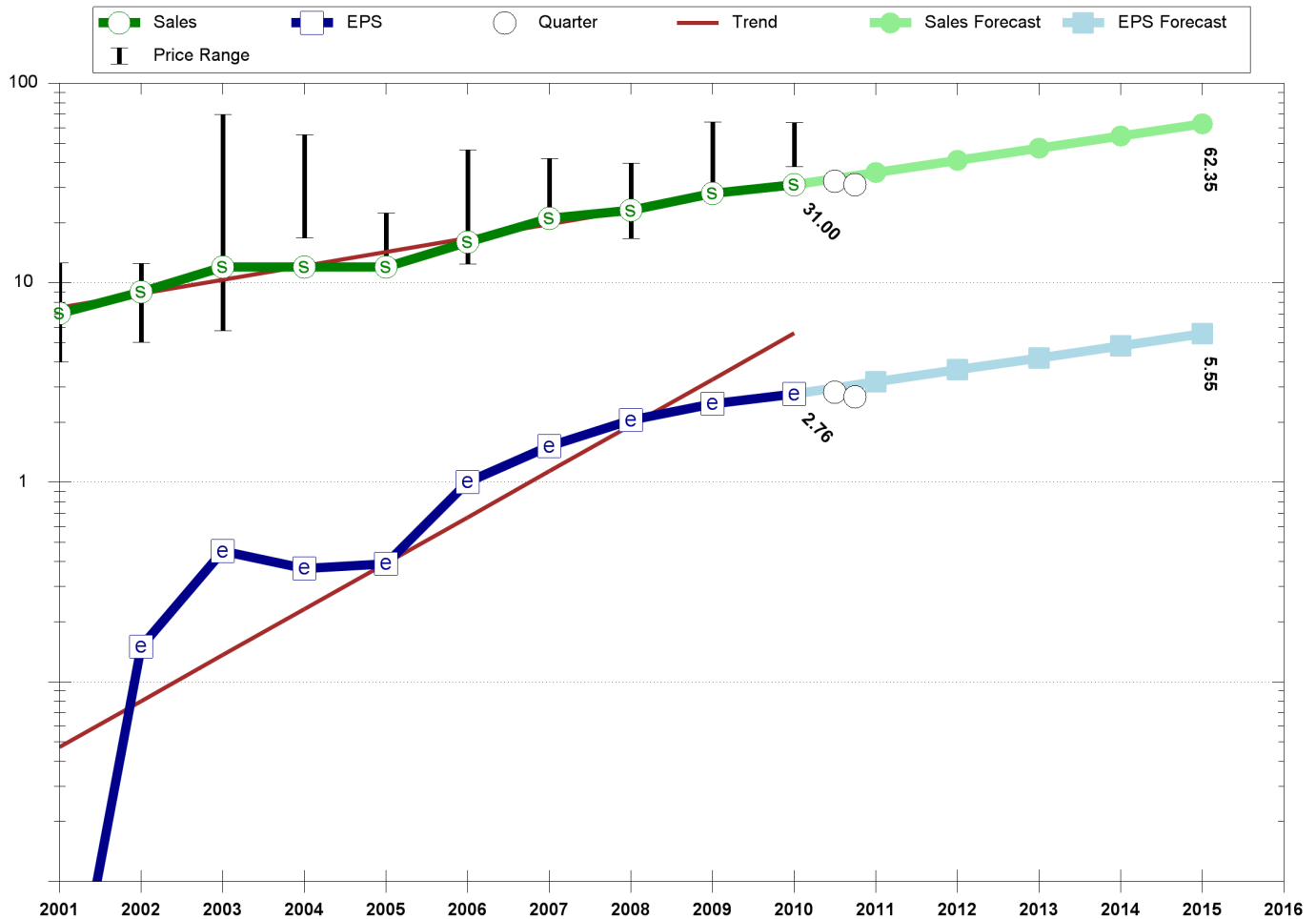

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 20.00 X Estimate High Earnings/Share 5.55 = Forecasted High Price \$ 111.00

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 11.89 X Estimate Low Earnings/Share 2.76 = Forecasted Low Price \$ 32.82

(b) Avg. Low Price of Last 5 Years 23.36

(c) Recent Market Low Price 30.36

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.000}{0.00\%} = 0.00$

C ZONING using 25%-50%-25%

Forecasted High Price 111.00 Minus Forecasted Low Price 32.82 = 78.18 Range. 25% of Range 19.55

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{111.00 - 55.03}{55.03 - 32.82} = \frac{55.97}{22.21} = 2.52$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price}}{\text{Present Market Price}} = \frac{111.00}{55.03} = 2.02$ X 100 = 201.71 - 100 = 101.71 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.000}{55.03} = 0.00 = 0.00\%$ Present Yield
